## NATIONAL ARTS COUNCIL- ARTS EDUCATION PROGRAMME PUBLIC ARTS PROGRAMME (Overseas Programmes)

This letter of eligibility ("**Letter of Eligibility**") confirms that the following programme stated in the table below has been accepted under the National Arts Council - Arts Education Programme ("**NAC-AEP**") **Public Arts Programme**.

Pre School, Pri Lower, Pri Upper, Special Education School may use either the Tote Board Arts Grant for Mainstream & Special Education schools ("**Grant**") or the NAC funding for Pre-schools ("**Funding**") to subsidise the programme cost.

There is a subsidy of up to 50% of the NAC-AEP programme cost for Mainstream schools, and up to 70% subsidy of the NAC-AEP programme cost for Special Education Schools. Schools may use **no more than 40%** of the total annual grant on overseas programmes.

Eligible pre-schools should approach their Head Quarters for more details on the Funding for Pre-school NAC-AEP programmes.
